What is a CAJA?

A Court Appointed Juvenile Advocate, (CAJA) is a trained community volunteer appointed by the Juvenile court to advocate for children in foster care who have experienced abuse and neglect. CAJAs get to know the child, gather information, work with professionals, and provide the court with an independent perspective focused on the best interest of the child.

What We Ask

We are looking for caring, committed community members who are willing to:

Spend time getting to know a child.

Visit with the child regularly.

Attend court hearings and meetings as needed.

Complete written reports for the court.

Remain committed to the child throughout the life of the case.
